# DID YOU KNOW...



...that donations made to the LSGO lower tuition costs for students who might not have been able to go to RRLS without such financial support?

...that within limits, LSGO giving doesn't cost you a cent but adds a significant benefit to families and students of RRLS? Determine how many tax dollars you can convert to scholarship dollars at https://lsgoohio.org/

...that while you can donate up to \$750 for an individual and \$1,500 for a married couple, it could be less if your tax liability is less than these prescribed maximum amounts?

...you can make a donation on behalf of the 2023 tax year up through April 14, 2024? (However, you may want to donate no later than March 31, 2024 as you will need to include the receipt of payment from the LSGO for your tax return.)

...you can break up your donation over a period of months as long as the total donations do not exceed \$750 for an individual or \$1,500 for a married couple?

...you can set up a monthly recurring donation of up to \$62.50/month for an individual (\$750 in total/year) or \$125 per month for a married couple (\$1,500 in total/year)?

...that even if you have had Ohio taxes withheld that would produce a refund, you can still donate up to the prescribed limits for individuals (\$750) and married couples (\$1,500) and simply obtain a greater refund by the amount you donated to the LSGO?

...that you can reduce your Ohio tax withholding by the amount you donate to the LSGO so your monthly income remains unchanged?
